BLACK HAWK MASTERBREEDERS CLUB

Black Hawk MasterBreeders Club Terms & Conditions

1. Only breeders who fulfil the following requirements can apply to become a Black Hawk MasterBreeder:

- Two or more breeding bitches/queens and one or more stud males in total
- Hold a financial State body, Dogs NZ (NZKC), Cat fancy or Cats Inc membership number
- Hold a financial Registered Prefix for cat and dog breeders

2 Black Hawk / Masterpet reserve the right to decline, suspend or terminate your membership of the Black Hawk MasterBreeders Club at any time.

3. Your Membership number and purchases are strictly for personal use only and must not be re-sold or given to any third party. Products included in Puppy and Kitten Packs are the only exception.

4. With regards to NZ Dog Breeders only, Black Hawk/Masterpet reserve the right to forward your details to Dogs New Zealand (formally NZKC) on application, and on a yearly basis, to ensure that you remain a financial member of this body. In the event that your membership of Dogs New Zealand has lapsed, we will contact you and you will have 30 days to ensure that your membership is up to date.

Puppy & Kitten Packs

5. Puppy and Kitten Packs will only be sent out on completion of a [Litter Support form](#) which must accompany a paid order of Black Hawk Puppy or Adult food. A maximum of 10 packs applies per litter

6. Any litter registration details provided on the application form must be correctly disclosed and, in accordance with details given to the relevant State body, Dogs NZ (NZKC), or Cat affiliate, and accurately reflect the number of puppies or kittens in a litter. If any details provided to us are found to be incorrect, we reserve the right to terminate your MasterBreeders Club Membership.

7 All product provided with Puppy and Kitten packs is to be passed on to the new owners of the puppy/kitten. We reserve the right to terminate any breeders MasterBreeders Club membership if they are found to be holding any food samples or packs.

MasterBreeder Shop Terms and Conditions

1. Orders are to be placed online. Payment in full for the goods must be made at the time that the order is placed. Payment can be made by credit or debit card. Once payment has been received by us we will confirm that your order has been accepted by sending an email to you at the email address you provide in your order form. Goods will be dispatched within 72 hours of funds being cleared to our account.

2. The prices payable for goods that you order are as set out on our website and are current as at the time you place and pay for your order.

4. Fulfilment of your Orders

We reserve the right to cancel the order between us if:

4.1 We have insufficient stock to deliver the goods you have ordered;

4.2 We do not deliver to your area; or

4.3 One or more of the goods you ordered was listed at an incorrect price due to a typographical error or an error in the pricing information.

4.4 If we do cancel your order we will notify you by e-mail and will re-credit to your account any sum deducted by us from your credit card as soon as possible but in any event within 30 days of your order.
